

### **Disclaimer of liability**

The participant takes part in our event at their own risk. They bear sole responsibility under civil and criminal law for all damage caused by them or the motorcycle used by them, as far as no exclusion of liability is agreed upon. In particular, the participant is liable to the organizer for the motorcycle and any associated personal injury, property damage and financial loss. Third party claims to the organizer for compensation for damage caused by the participant, keeps liability from the organizer at first request. The participant is liable for damages to the motorcycle used by the participant through their own fault or negligence, as a result of accidents or improper handling, or that result from the participant not following the instructions of the organizer's employees. With their signature, the participant declares the waiver of claims of any kind for damages that arise in connection with the event, namely against the organizer, the property owner, all authorized beneficiaries on the property, the road construction agency and other persons involved in the organization of the event that are in contact and to the vicarious agents of all the aforementioned persons and bodies, except for damage resulting from injury to life, body or health, which is due to an intentional or negligent breach of duty - including a legal representative or vicarious agent of the group of persons exempted from liability - are based, and except for other damages that are based on an intentional or grossly negligent breach of duty - also by a legal representative or a vicarious agent of the group of persons exempted from liability; they waive any claims for damage arising in connection with the event against the other participants (drivers, passengers), their helpers, the owners or keepers of the motorcycles, except for damage resulting from injury to life, body or the Health that is based on an intentional or negligent breach of duty - including by a legal representative or a vicarious agent of the group of persons exempted from liability - and except for other damage based on an intentional or grossly negligent breach of duty - including by a legal representative or a vicarious agent of the group of persons exempted from liability. However, the disclaimer of warranty does not cover claims against liability and accident insurance and for claims against participants and organizers covered by this insurance. The insurance was taken out on the usual terms. The disclaimer of warranty becomes effective with the signature of the participant towards all parties involved. It applies to claims based on any legal reason, in particular both for claims for damages from contractual and non-contractual liability and also for claims from unlawful acts. Implicit liability exclusions remain unaffected by the above liability exclusion clause.

Furthermore, the participant assures that they have no physical handicaps and are not under the influence of alcohol, drugs or medication that could affect their ability to drive in any way. We expressly point out the particular risk posed to people with heart problems and high blood pressure. In this respect, the lawful traffic regulations also apply. If the participant has not yet reached the age of 18, their parents or the legal representative are liable. Participation in the event without prior submission of the disclaimer is not possible.
